Health hazard: Polyisoprene is generally considered non-hazardous and is safe for use by persons who know they are susceptible to natural latex allergies. However, the product contains higher levels of dithiodicarbamate than natural latex rubber and consequently may cause sensitization by skin contact and give rise to Type IV Allergies. Persons who know they are susceptible to dithiocarbamates should avoid contact with polyisoprene. N-Nitrosamine by-products of dithiocarbamate are below BSEN12868 limits.
